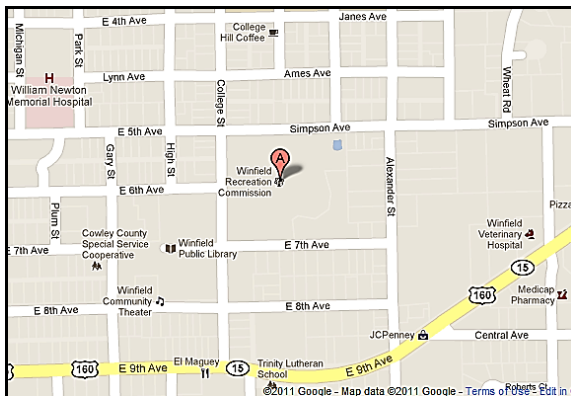

I HEREBY WAIVE, RELEASE, HOLD HARMLESS, PROMISE NOT TO SUE AND INDEMNIFY PTI, LAW ENFORCEMENT AGENCIES, ALL PUBLIC ENTITIES AND THEIR AGENTS, OFFICIALS AND EMPLOYEES ("Released Parties") FROM ANY and all rights and CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASED PARTIES' OWN NEGLIGENCE, which I may have for any damages sustained by me in connection with my participation in any event, or travel to or from any event.

I agree, should I assert claims prohibited by this agreement, I shall be liable for expenses (including legal fees) incurred by the defending party unless the defending party is finally adjudged liable. This agreement shall bind my heirs, legal representatives, successors or assigns.
